ASSIGNMENT

THIS ASSIGNMENT effective the 6th day of September 2005.

BETWEEN

SIMON ROBERT MILLER, a British subject of Grouse Lodge,
Milltownpass, Co. Westmeath, Ireland, (hereinafter called "the author") of the
one part; and

TRUpour LIMITED, an Irish company of Templemichael Business Park,

WHEREAS the author claims to be the true and first author of a design
relating to "Beverage Dispense Valve " (hereinafter referred to as "the design")
and for which a design application is about to be filed,

AND WHEREAS the author has agreed for the consideration hereinafter
appearing to assign and transfer into TRUpour Limited all his right title and
interest in and to the design including copyright in the design,

NOW THIS ASSIGNMENT WITNESSETH that:

1. In consideration of the sum of €10.00 (Ten Euro) which has been paid by
TRUpour Limited to the author (receipt of which is hereby acknowledged) and
other good and valuable consideration, the author hereby assigns to TRUpour
Limited absolutely the design, any design right or any copyright therein
together with all rights and interests in the same including the right to a design
registration and all rights and powers to make applications for registration of
designs in the name of TRUpour Limited, or in the name of their assignee or
nominee, in the European Union and in any other country of the world in
respect of the design, together with all rights and benefits arising therefrom
under the International Convention for the Protection of Industrial Property or
the Treaty Establishing the World Trade Organisation.

2. The author hereby covenants with TRUpour Limited as follows:

(i) that he will (so far as necessary) permit and enable TRUpour Limited to apply for and will take all reasonable steps to assist TRUpour Limited or its assignee or nominee in obtaining the registration of a design or like protection in respect of the design hereinbefore assigned in any territory as may be required by TRUpour Limited

(ii) that he will at the request and cost of TRUpour Limited execute and do all such documents, acts and things as may be necessary for the purpose of subparagraph (i) hereof and for vesting any relevant design, application for registration of design, any design right or copyright in TRUpour Limited or its assignee or nominee absolutely.




4. This assignment relates to rights in the design and does not include or affect any rights in an invention or patentable subject matter.
