



ASSIGNMENT

4. 5. 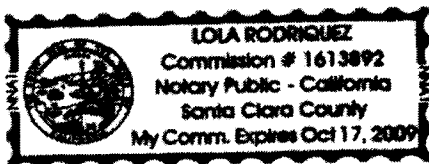
