**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
JACOBSON FAMILY HOLDINGS, LLC**

ARTICLE I

The name of the Company is MacArthur Investments, LLC. ✓

ARTICLE II

The address of the registered office of the Company in Minnesota is 225 South Sixth Street, Suite 4000, Minneapolis, Minnesota 55402. ✓

ARTICLE III

The duration of the Company shall be perpetual.

ARTICLE IV

Notwithstanding the occurrence of an event which terminates the continued membership of a member of the Company (including those events described in Minnesota Statutes, Section 322B.80, subdivision 1, clause (5), (i) through (xii)), the Company shall not be dissolved and shall not be required to be wound up by reason of the event that terminates the continued membership of a member, if, after such event, (1) there is at least one remaining member, or (2) the membership of the last or sole member terminates and the legal representative of that last or sole member, or of the estate of such member, causes the Company to admit at least one member within 180 days after such membership termination.

ARTICLE V

No member of the Company shall have any cumulative voting rights.

ARTICLE VI

No member of the Company shall have any preemptive rights.

ARTICLE VII

A governor of the Company shall not be personally liable to the Company or its members for monetary damages for breach of fiduciary duty as a governor except for liability of a governor (i) for any breach of the governor's duty of loyalty to the Company or its members, (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, (iii) under section 322B.56 or 80A.23 of the Minnesota Statutes, (iv) for any transaction from which the governor derived an improper personal benefit, or (v) for any act or omission occurring prior to the effective date of this Article. No amendment to or repeal of this Article shall apply to or have any effect on the liability or alleged liability of any governor of the Company for or with respect to any acts or omissions of such governor occurring prior to such amendment or repeal.
