

Assignor does hereby covenant and agree with Assignee, its successors and assigns, that Assignor will not execute any writing or do any act whatsoever conflicting with these presents, and that Assignor will at any time upon request, without further or additional consideration, but at the expense of Assignee, its successors and assigns, execute such additional writings and do such additional acts as Assignee, its successors and assigns, may deem necessary or desirable to perfect Assignee's enjoyment of this grant, and render all necessary assistance in making applications for and obtaining original, divisional, reissued or extended patents of the United States and any and all foreign countries on the Invention, and in enforcing any rights accruing as a result of patent applications or patents claiming the Invention, by giving testimony in any proceedings or transactions involving such applications or patents.
