**CONFIRMATORY PATENT ASSIGNMENT**

**WHEREAS**, by virtue of an Asset Transfer Agreement entered into by **PeopleSoft, Inc.** ("**PeopleSoft**"), a Delaware corporation, with a former place of business at 4460 Hacienda Drive, Pleasanton, California 94588, and **J.D. Edwards & Company, LLC** ("**JDE LLC**"), a Delaware limited liability company with a former place of business at One Technology Way, Denver, Colorado 80237, **PeopleSoft** and **JDE LLC**, together with **J.D. Edwards World Source Company** ("**JDE World Source**"), a Colorado corporation with a former place of business at One Technology Way, Denver, Colorado 80237, hereinafter referred to collectively as "**Assignors**"; and **Oracle Corporation** ("**Oracle Corporation**"), a Delaware corporation, with its place of business at 500 Oracle Parkway, Redwood Shores, California 94065, hereinafter referred to as "**Oracle**"; and **Oracle International Corporation** ("**OIC**"), a California corporation and wholly-owned subsidiary of **Oracle**, with a place of business at 500 Oracle Parkway, Redwood Shores, California 94065, hereinafter referred to as "**Assignee**"; on March 1, 2005, certain steps were effected in a series of transactions for the reorganization of **Oracle** and certain of its subsidiaries, which transactions were to include (i) the merger of **Assignors** with and into **Oracle**, with **Oracle** as the surviving entity; and (ii) the assignment, transfer, conveyance and delivery by **Assignors** to **Assignee**, its successors, legal representatives and assigns, **Assignors'** entire right, title and interest in, to, and under the issued patents and provisional and non-provisional pending applications listed on the attached Schedule A, as well as any divisions, renewals and continuations thereof, and all Letters Patent of the United States which may be granted thereon and all reissues and extensions thereof, and all applications for Letters Patent which may hereafter be filed for inventions embodied by said pending applications in any country or countries foreign to the United States, and all Letters Patent which may be granted for said inventions embodied by said pending applications in any country or countries foreign to the United States and all extensions, renewals and reissues thereof and all rights of priority in any such country or countries based upon the filing of said pending applications in the United States which are created by any law, treaty or international convention, together with the right to sue for and recover damages for past infringement of any such patents.

The Commissioner of Patents of the United States, and any Official of any country or countries foreign to the United States, whose duty is to issue patents on any such applications as aforesaid, is hereby authorized and requested to issue all Letters Patent for said inventions to **Assignee**, its successors, legal representatives and assigns, in accordance with the terms of these agreements.
