AGREEMENT

This Agreement is entered into by and between Dorcy International, Inc., an Ohio corporation, having its principal place of business at 2700 Port Road, Columbus, Ohio 43217 and Flying Dragon Development, Ltd., a Hong Kong company having a place of business at 27-31 Au Pui Wan Street Fo Tan, Shatin, N.T., Unit B, 6/F Unison Industrial Centre, Hong Kong, Sar, China and is effective as of December 28, 2004.

- A. Flying Dragon Development, Ltd. ("Flying Dragon") owns the United States patents identified in Exhibit A hereto ("the Patents").
- B. By virtue of its relationship with Flying Dragon, Dorcy International, Inc. ("Dorcy") has been selling, offering for sale and distributing various products that are covered by the Patents.
- C. Dorcy has been the exclusive, authorized practioner of the inventions described in the Patents since issuance of each of the Patents and, as a result, has expended substantial resources in developing the U.S. market for such products.
- D. Flying Dragon and Dorcy desire to execute this Agreement to confirm Dorcy's past exclusive rights to practice the Patents and to hereby transfer, convey and assign the Patents from Flying Dragon to Dorcy.

NOW THEREFORE, for and in consideration of the foregoing, the parties hereto agree as follows:

- 1. Assignment. Flying Dragon hereby assigns, transfers and conveys to Dorcy the Patents, and any all applications, divisions, reissues, reexamination certificates, continuations or continuations-in-part that concern or relate to the inventions disclosed in each of the Patents within the United States ("Patent Rights").
- 2. Right to Sue. Flying Dragon hereby grants to Dorcy the right to sue and pursue all remedies including, but not limited to, recovery of damages for all acts of infringement of the Patents or the Patent Rights, including all acts of infringement that occurred since issuance of the Patents or before the execution of this Agreement.
- 3. Miscellaneous. The construction and performance of this Agreement shall be governed by and shall be subject to the laws of Ohio without regard to its conflicts of laws provisions.
- 4. Supply of goods. Dorcy agrees that all the goods manufactured in accordance with the Patents must all be sourced from and /or throught Flying Dragon.
- 5. Reverse Right. Upon the written request of Flying Dragon, Dorcy must within reasonable time assign, transfer and convey the Patents back to Flying Dragon
