ARTICLES OF CONVERSION Corporations Section

Pursuant to the provisions of Article 10.08 and 10.09 of the Texas Limited Liability Company Act and Section 2.15 of the Texas Revised Limited Partnership Act, REYNOLDS INTERNATIONAL EQUIPMENT, LLC, a Texas limited liability company (hereinafter referred to in these Articles of Conversion as the "Converting Entity"), has adopted the following Articles of Conversion for the purpose of converting its organizational form from a limited liability company into a limited partnership organized under the laws of the State of Texas under the name REYNOLDS INTERNATIONAL EQUIPMENT, L.P. (hereinafter referred to in these Articles of Conversion as the "Converted Entity") in accordance with the provisions of the Texas Limited Liability Company Act and the Texas Revised Limited Partnership Act.

1. It is hereby certified by the undersigned that:
 - (a) The legal name of the Converting Entity is REYNOLDS INTERNATIONAL EQUIPMENT, LLC, and the Converting Entity is a limited liability company organized under the laws of the State of Texas;
