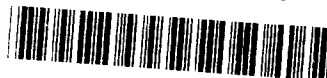

# ASSIGNMENT


