WHEREAS, we represent and warrant that we are the sole owners of said invention and application for Letters Patent; and






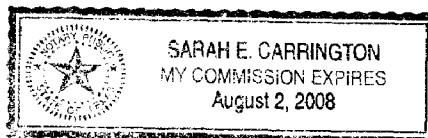
