We, Thomas Hoang, Matthew Evans, Christopher Busso, Tyler Cox, Kenneth Johnson who reside respectively at 182 Cambridge Court, Clifton, NJ 07014, 12 Hoover Court, Monroe, NY 10950, 49 Finnigan Ave., Apt. B-2, Saddle Brook, NJ 07663, 98 Browns Road, Westtown, NY 10998, 405 Sheffield Court, Brewster, NY 10509, have made certain inventions or discoveries (or both) set forth in an application for Letters Patent of the United States of America, entitled: HOUSING FOR TEST AND MEASUREMENT INSTRUMENT and LeCroy Corporation, whose address is 700 Chestnut Ridge Road, Chestnut Ridge, New York 10977-6499, and which, together with its successors and assigns is hereinafter called "Assignee", is desirous of acquiring the title, rights, benefits and privileges hereinafter recited, and of confirming the same or any part thereof heretofore acquired by Assignee.

2. Authorize Assignee to file patent applications in any or all countries on any or all of said inventions and discoveries in our names or in the name of Assignee or otherwise as Assignee may deem advisable, under the International Convention or otherwise;

3. Authorize and request the Commissioner of Patents of the

United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patent to Assignee, as assignee of the entire right, title and interest therein or otherwise as Assignee may direct;

4. 
