Assignor authorizes and requests the Commissioner for Patents of the United States, and any official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of intellectual property protection on applications for such protection, to issue the same to the Assignee, his successors, legal representatives, and assigns, in accordance with the terms of this agreement.

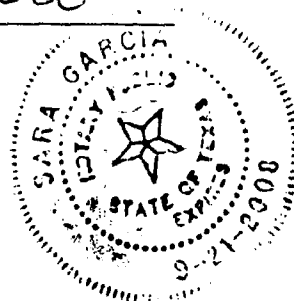
