## ASSIGNMENT

WHEREAS, WE,

**Fredrik Gustavsson**, a citizen of Sweden, residing at Farskinnsvägen 19, 58666

**Jonas Nilsson**, a citizen of Sweden, residing at Norgegatan 18, 58231 Linköping,  
Sweden; and

ASSIGNORS HEREBY authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property


protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.


