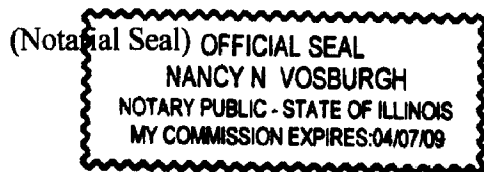
the invention covered by said patents, or to license or permit use of said invention, remain with Assignee and shall be assignable by Assignee without the consent of Robert Bosch GmbH.
