ASSIGNMENT

WHEREAS the Company is desirous of ensuring that it has acquired all right, title, and interest of the Assignor in and to said Patent Rights and Technology Rights.



resolution forum; and generally do all things which may be desirable or necessary in the view of the Company to vest, obtain, secure, perfect, maintain, or enforce any rights which are the subject of this Assignment.
