ASSIGNMENT

WHEREAS, we, David J. NEWMAN, a citizen of the United States and Garrett J. BARNUM, a citizen of the United States, hereinafter "ASSIGNORS", have, along with other co-inventors Matthew J. Friend, Douglas A. Drew, Gerardo Aguirre, and Ronald B. Easter, invented a new and useful **INTEGRATED DATA READER AND ELECTRONIC ARTICLE SURVEILLANCE (EAS) SYSTEMS** for which a patent application was filed on February 8, 2006 and assigned Serial No. 11/351,310 and for which provisional application Serial No. 60/651,058 was filed February 8, 2005 (collectively hereinafter "said invention");

ASSIGNORS hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement.

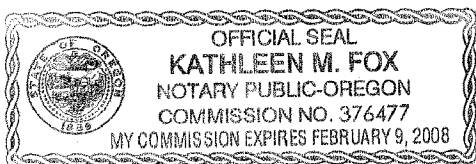


