

AND, in pursuance of this assignment, we do hereby further agree with the said Assignee that we will not do any act whatsoever conflicting with these presents and that we will at any time upon request, without demanding any further or additional consideration but at the expense of the said Assignee, execute such additional assignments and other documents and do all such additional lawful and reasonable just acts as said Assignee may deem necessary or desirable to perfect the Assignee's enjoyment of this grant, and render all necessary assistance in making application for and obtaining an original, divisional, reissued, or extended patent or patents in the United States, Canada or elsewhere on said invention or inventions or any part thereof, including the execution and acknowledgement of any further instruments and the giving of testimony in any proceedings or transactions that may be or become necessary or desirable for sustaining or reissuing any said patent, for enforcing any rights or chooses in action accruing as a result of any said application or patent, or for maintaining and perfecting the right of the Assignee to said invention or inventions, in whole and in part, and to any said patent, particularly in cases of interference and litigation, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of the Assignors and of the Assignee;

AND specifically in respect of the United States of America we request the Commissioner of Patents to issue any Letters Patent which may be issued for said invention or inventions, or for any part thereof, to said Assignee, its/his legal representatives, successors or assigns, as the sole owner of the entire right, title and interest in and to said Letters Patent and the invention(s) covered thereby;
