If the ASSIGNEES or their successors or assignees desire to make substitute, refile, division, or continuation applications for the invention, or to secure a reissue or extension of a Letters Patent for the invention, or to file a disclaimer relating to the invention, the ASSIGNOR covenants that he will at any time and upon request sign all papers, make all rightful oaths, and do all lawful acts necessary for these purposes, so long as such acts are at the expense of the ASSIGNEE making such request.

The ASSIGNOR acknowledges that his entire United States beneficial interest in the invention to which the above application relates is irrevocably vested in the ASSIGNEES, and that the ASSIGNEES shall hold all United States interests in the invention as fully and completely as they would have been held by the ASSIGNOR had this ASSIGNMENT not been made.

The ASSIGNOR covenants that he will at all times communicate to the ASSIGNEES, their successors, assigns, and legal representatives, all facts known to him relating to the invention and any applications or Letters Patent relating to the invention, and testify as to these facts in interferences or other litigation when requested to do so, so long as it is at the expense of the ASSIGNEE making such request.

The Commissioner of Patents is authorized and requested to issue a patent for the invention to the ASSIGNEES as collectively being the owners of the entire United States right, title and interest therein, with each ASSIGNEE owning an equal share of such right, title and interest.
