

FOR VALUE RECEIVED, We, **Kimmo ROIMELA**, a citizen of Finland residing at Annalankatu 17 C 9, FI-33710 Tampere, Finland; **Tomi AARNIO**, a citizen of Finland residing at Kaukametsäankatu 3 A 1, FI-33710 Tampere, Finland; and **Joonas ITÄRANTA**, a citizen of Finland residing at Pättiniemenkatu 17 D 12, FI-33270 Tampere, Finland, hereby sell, assign and transfer to **NOKIA CORPORATION**, an organization duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in **COMPRESSION OF IMAGES FOR COMPUTER GRAPHICS**, which is described in an application for Letters Patent of the United States filed on **January 24, 2006**, now bearing U.S. Patent Application Serial No. **11/339,341**; and all the rights and privileges under any and all Letters Patent that may be granted therefor.

We request that any and all patents for said inventions in all countries be issued to said assignee, its successors, assigns and legal representatives, or to such nominees as it may designate.

We agree that, when requested, we will, without charge to said assignee but at its expense, sign all papers, take all rightful oaths, and do all acts which may be necessary, desirable or convenient for securing and maintaining patents for said inventions in any and all countries and for vesting title thereto in said assignee, its successors, assigns and legal representatives or nominees.

We authorize and empower the said assignee, its successors, assigns and legal representatives or nominees, to invoke and claim for any application for patent or other form of protection for said inventions filed by it or them, the benefit of the right of priority provided by: (a) the International Convention for the Protection of Industrial Property, as amended, or by any convention which may henceforth be substituted for it; and (b) the Patent Cooperation Treaty, as amended, or by any treaty which may henceforth be substituted for it; and to invoke and claim such right of priority without further written or oral authorization from us.
