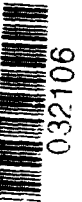


ASSIGNMENT
