ASSIGNMENT

WHEREAS I, James Wahl, a citizen of the United States, residing at 2912 Byer Ridge Court, Export, Pennsylvania 15632; Andres Viduya, a citizen of the United States, residing at 615 Redwood Court, Cranberry Township, Pennsylvania 16066; Ben Kessing, a citizen of the United States, residing at 220 Rockingham Road, Pittsburgh, Pennsylvania 15238; Roger Graham Byford, a citizen of the United States, residing at 942 Monroe Court, Apollo, Pennsylvania 15613-9245; James Randall Logan, a citizen of the United States, residing at 24 Hancock Farms, Pittsburg, Pennsylvania 15238; Dominic Tooze, a citizen of the United Kingdom, residing at 29 Devonport Road, London, England W12 8NZ; Philip Shade, a citizen of the United Kingdom, residing at 10D Veronica Road, London, England SW17 8QL and Graham Lacy, a citizen of the United Kingdom, residing at 19 Gosberton Road, Balham, London, England SW12 8LE (hereinafter referred to collectively as "ASSIGNOR"), have invented a HEADSET TERMINAL WITH SPEECH FUNCTIONALITY, for which an application for Letters Patent of the United States was filed with the United States Patent and Trademark Office on February 6, 2006, and was assigned Serial No. 11/347,979.

WHEREAS, Vocollect, Inc., a corporation organized under the Laws of the State of Pennsylvania, and having its principal office at 703 Rodi Road, Pittsburgh, Pennsylvania 15235 (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring the entire interest therein:

NOW THEREFORE, in consideration of the sum of One Dollar (\$1.00) to me in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, I the said ASSIGNOR, hereby sell, assign, and transfer and set over, unto the said ASSIGNEE, its successors, legal representatives and assigns, the entire right, title and interest in, to and under the said invention, and the said United States application and all divisions, renewals, and continuations thereof, and all Patents of the United States which may be granted thereon and all reissues, reexaminations and extensions thereof; and all applications for industrial property protection, including, without limitation, all applications for patents, utility models, and designs which may hereafter be filed for said invention in any country or countries foreign to the United States, together with the right to file such applications and the right to claim for the same the priority rights derived from said United States application under the Patent Laws of the United States, the Paris Convention for the Protection of Industrial Property, the International Patent Cooperative Union, European Patent Convention, Common Market Convention, or any other Convention or Union, or any other international agreement or the domestic laws of the country in which any such application is filed, as may be applicable; and all forms of industrial protection, including, without limitation, patents, utility models and designs which may be granted for said invention in any country or countries foreign to the United States and all extensions, renewals, reexaminations and reissues thereof;

And I further agree to execute all necessary or desirable and lawful future documents, including assignments in favor of ASSIGNEE or its designee, as ASSIGNEE or its successors, assigns and legal representatives may from time-to-time present to me and without further remuneration, in order to perfect title in said invention, modifications, and improvements in said invention, applications and Letters Patent of the United States and countries foreign thereto.

And I further agree to properly execute and deliver and without further remuneration, such necessary or desirable and lawful papers for application for foreign patents, for filing subdivisions of said application for patent, and or, for obtaining any reissue or reissues of any Letters Patent which may be granted for my aforesaid invention, as the ASSIGNEE thereof shall hereafter require and prepare at its own expense.

ASSIGNOR HEREBY authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument.

ASSIGNOR HEREBY grants the firm of Wood, Herron & Evans, LLP, the power to insert in this Assignment any further identification or information, including Serial No. and/or Filing date in spaces that follow, which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.


