ASSIGNMENT

WHEREAS, Daniel D. Schnackenberg, residing at Auburn, Washington, Kelly S. Bunn, residing at Duvall, Washington, Thomas E. Donofrio, residing at Federal Way, Washington, Steven L. Arnold, residing at Kirkland, Washington, Travis S. Reid, residing at Seattle, Washington, and Ryan D. 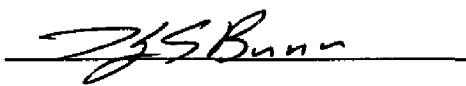
