TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT, dated as July 29, 1998 by **Venture Capital Fund of New England, III, L.P.**, a limited partnership with an address of 160 Federal Street, Boston Massachusetts ("Venture"); **Zero Stage Capital V LP**, a limited partnership with an address of 101 Main Street, Cambridge, Massachusetts ("Zero Stage"); **Morton E. Goulder**, an individual with an address of 97 Ridge Road, Hollis, New Hampshire ("Goulder"); **Baxter Healthcare Corporation**, a Delaware corporation with an address of One Baxter Parkway, Deerfield, Illinois ("Baxter", and together with Venture, Zero Stage and Goulder, the "Interest Holders") and Solidscape, Inc. f/k/a Sanders Prototype, Inc., a Delaware corporation ("Solidscape").

WHEREAS, Solidscape and the Interest Holders entered into a Patent Security Agreement, dated as of July 29, 1998 (the "Agreement"), which Agreement was recorded November 16, 1998, with the United States Patent and Trademark Office at Reel 009596, Frame 0266 for the purpose of securing payment and performance of obligations of Solidscape;

WHEREAS, the Interest Holders have agreed to terminate and release the Agreement and transfer to Solidscape their right, title and interest in the patents listed on Exhibit A attached hereto;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Interest Holders hereby terminate and release the Agreement and assign and transfer to Solidscape, without representation, warranty or recourse, all of Interest Holders' right, title and interest in and to the patents listed on Exhibit A attached hereto, effective as of the date set forth above.
