**ASSIGNMENT**

**WHEREAS, WE, James HALVIS, a citizen of the United States, residing at 549 Devonshire Court, Severna Park, Maryland 21146; and Richard Calve McKEE, a citizen of the United States, residing at 2612 Haven Oak Court, Ellicott City, Maryland 21042, are the inventors of an invention in SPECTRAL FILTER FOR OPTICAL SENSOR for which we have executed an application for Letters Patent of the United States, of even date herewith; and**
