

Deed of Acknowledgement and Assignment**DATED:** 28 February 2006**BETWEEN:** PETER SAMUEL VOGEL of 30 Adeline St Faulconbridge NSW 2776 (the "Assignor");**AND:** GAIA TECHNOLOGY PTY LTD (ACN 113 051 111) of L2, 84 Pitt St, Sydney 2000 ("Gaia Technology").**DEED:****1. Definitions****1.1** In this deed, except to the extent the context otherwise requires:

- (a) "Encumbrances" includes a mortgage, charge, lien and any other third party interest;
- (b) "Intellectual Property Rights" includes, without limitation, any and all beneficial and legal ownership and intellectual and industrial protection rights throughout the world, both present and future, including rights in respect of or in connection with any confidential information, trade secrets or know-how; copyright and rights in the nature of or analogous to copyright; inventions, discoveries or new processes; manners, methods or processes of manufacture; methods or principles of construction; computer programs; integrated circuits, circuit layouts or semiconductor chip layouts or designs; plans, drawings or designs; technical or engineering information or documents; patents, patent applications (including any divisions, continuations, continuations in part, extensions and foreign equivalents thereof) and includes any right to apply for the registration of such rights and includes all renewals and extensions.

2. Acknowledgement that Mr Vogel was an employee of Right Hemisphere Pty Limited**2.1** Mr Vogel acknowledges and warrants that:

- (a) he was an employee of Right Hemisphere Pty Limited (ACN 003 516 630) during the period 16 May 1988 to 1 March 2003 (the "RH Employment Period");
- (b) during the RH Employment Period, he developed all Intellectual Property Rights incorporated in or connected with the patents and patent applications set out in Schedule 1;
- (c) he is aware that by deed of assignment dated 30 January 2001, Right Hemisphere Pty Limited assigned all Intellectual Property Rights in the patents and patent applications set out in Schedule 1 to VideoZap Pty Limited (ACN 093 767 367); and
- (d) as at 30 January 2001, Right Hemisphere Pty Limited was the owner of all right, title and interest in all Intellectual Property Rights in the patents and patent applications set out in Schedule 1 free of all Encumbrances and had the right to assign those rights to VideoZap Pty Limited.

2.2 To the extent that Mr Vogel retains any rights, title or interest in the Intellectual Property Rights incorporated in or connected with the patent set out in Item 7 and Item 9 of Schedule 1 and the patent application set out in Item 8 of Schedule 1, Mr Vogel hereby assigns all such rights, title and interest to Gaia Technology free of all Encumbrances.

3. Acknowledgement that Mr Vogel was an employee of VideoZap Pty Limited**3.1** Mr Vogel acknowledges and warrants that:

- (a) he was an employee of VideoZap Pty Limited (ACN 093 767 367) during the period 14 July 2000 to 1 February 2005 (the "VideoZap Employment Period");
- (b) during the VideoZap Employment Period he developed:

- (i) all Intellectual Property Rights incorporated in or connected with Australian Provisional Patent Application Number 2004900624; and
 - (ii) certain Intellectual Property Rights associated with electronic program guides and personal video recorders;
 - (c) he is aware that, pursuant to an agreement for sale of assets dated 16 March 2005 between ZapTV Pty Limited (ACN 093 767 367) (administrators appointed), Daniel Civil and Peter Rogers, Gaia Technology and Mr Vogel, ZapTV Pty Limited sold all its right, title and interest in Australian Provisional Patent Application Number 2004900624 and the Intellectual Property Rights described in clause 3.1(b)(ii) to Gaia Technology; and
 - (d) ZapTV Pty Limited was the owner of all right, title and interest in the Intellectual Property Rights set out in clauses 3.1(b)(i) and 3.1(b)(ii) free from all Encumbrances and had the right to assign those rights to Gaia Technology.
- 3.2 To the extent that Mr Vogel retains any rights, title or interest in the Intellectual Property Rights set out in clauses set out in clauses 3.1(b)(i) and 3.1(b)(ii), Mr Vogel hereby assigns all such rights, title and interest to Gaia Technology free of all Encumbrances.

- 4.1 Promptly, upon the request of Gaia Technology, Mr Vogel consents that he will:




