


WHEREAS, ITAG wishes to confirm that it has acquired and accepted all right, title and interest in the PATENT RIGHTS;

This assignment shall include the right to claim priority under any treaty or convention for any of the PATENT RIGHTS, and shall include the right to sue for and collect past damages. SIEMENS further hereby covenants and agrees to execute all instruments or documents required or requested by ITAG (or any successor-in-interest to any of the PATENT RIGHTS) in connection with perfecting title to, obtaining, and/or enforcing any of the PATENT RIGHTS or related rights, without further or other compensation. ITAG does hereby confirm, acquire, and accept such assignment and transfer of all of the above PATENT RIGHTS and related rights.
