ASSIGNMENT

WHEREAS, we, Young Ki LEE, a citizen of the Republic of Korea, residing at Buyoung Apt. 607-302, Gupyoung-dong, Gumi-si, Kyongsangbuk-do, Republic of Korea; Dong Hak KWAK, a citizen of the Republic of Korea, residing at 736-1 Inwang-dong, Kyoungju-si, Kyongsangbuk-do, Republic of Korea; Hui Chan YUN, a citizen of the Republic of Korea, residing at 1159-3 Maegok-ri, Dasaeup, Dalseong-gun, Daegukwangyeok-si, Republic of Korea; and Jong Seob KIM, a citizen of the Republic of Korea, residing at Sejong Apt. 109-1208, Jeonmin-dong, Yuseong-ku, Daejeonkwangyeok-si, Republic of Korea, (hereinafter referred to as "ASSIGNORS"), are the joint inventors of certain new and useful improvements in A CATHODE MATERIAL FOR SECONDARY BATTERIES WITH NON-AQUEOUS ELECTROLYTE, A PROCESS FOR PREPARING THE CATHODE MATERIAL AND LITHIUM SECONDARY BATTERY CONTAINING THE SAME (hereinafter referred to as "invention"), for which an application for United States Letters Patent has been executed by us concurrently herewith, and which application claims priority from Korean Application No. 10-2005-0020601, filed March 11, 2005, all applications listed above being hereinafter referred to as the "application"; and

WHEREAS, CHEIL INDUSTRIES INC., a corporation existing and organized under the law of the Republic of Korea (hereinafter referred to as "ASSIGNEE"), having a principal place of business at 290, Gongdan 2-dong, Gumi-si, Gyeongsangbuk-do, Korea, is desirous of acquiring the entire right, title, and interest in and to said invention as described in said application, and in and to any and all

Letters Patent that shall be granted therefore in the United States of America and all foreign countries;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, the ASSIGNORS, have sold and by these presents do hereby sell, assign, transfer, and convey unto the ASSIGNEE, its successors and assigns, the entire right, title, and interest in and to said invention and said application, and in and to any and all continuations, continuations-in-part, or divisions thereof, and in and to any and all Letters Patent of the United States of America and all foreign countries or reissues thereof that may be granted therefore or thereon, for the full term for which said Letters Patent may be granted, together with the right to claim the priority of said application in all foreign countries in accordance with international treaties and conventions, the same to be held and enjoyed by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by us if this assignment and sale had not been made.

We hereby request that said Letters Patent be issued in accordance with this assignment.

We further covenant and agree that, at the time of the execution and delivery of these presents, we possess full title to said invention and said application, and that we have the unencumbered right and authority to make this assignment.

We further covenant and agree to bind our heirs, legal representatives, and assigns, promptly to communicate to said ASSIGNEE or its representatives any facts known to us relating to said invention, to testify in any interference

or legal proceedings involving said invention, to execute any additional papers that may be requested to confirm the right of the ASSIGNEE, its representatives, successors or assigns to secure patent or similar protection for said invention in all countries and to vest in the ASSIGNEE complete title to said invention and Letters Patent, without further compensation, but at the expense of said ASSIGNEE, its successors, assigns and other legal representatives.


