RELEASE OF SECURITY INTEREST IN PATENTS

THIS RELEASE OF SECURITY INTEREST IN PATENTS (this "Release") is made as of the 17th day of May 2006 by and between Comerica Bank (as successor-by-Merger to Comerica Bank-California, successor by Merger to Imperial Bank formerly organized under the laws of California), with its principal office at Comerica Tower at Detroit Center, 500 Woodward Avenue, Detroit, Michigan 48226 ("Grantee") and Ramco Industries, Inc., an Indiana Corporation, with its principal office at 420 Roske Drive, Elkhart, IN 46516 ("Grantor")

WHEREAS, pursuant to the terms and conditions of that certain Patent Security Agreement by and between Grantor and Grantee dated April 30, 1999 (the "Patent Security Agreement"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the patents and patent applications owned by Grantor (collectively, the "Patents", including, without limitation, the United States patents set forth on Schedule A attached hereto;

WHEREAS, Grantor and Grantee entered into the Patent Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and between Grantor and Grantee dated April 30, 1999 (the "Security Agreement");

WHEREAS, the Patent Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on May 11, 1999, at Reel 009942, Frame 0122; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Patent Security Agreement and the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against Patents.


