The said ASSIGNOR hereby authorizes and requests the Commissioner of Patents and Trademarks to issue any Letters Patent which may be granted for said inventions to the said ASSIGNEE as the assignee of the entire right, title and interest therein.

Expressly excluded from this assignment are the rights of Debt Resolve, Inc. and the ASSIGNOR under that certain Limited License Agreement dated February 20, 2003 (as same has heretofore been amended, and as same may hereafter be amended, modified, supplemented and/or restated from time to time).
