

I agree for myself and for my heirs, executors and administrators to communicate to said ZEISS JENA, its successors, assigns, nominees or other legal representatives, all facts known to me respecting said improvements, whenever requested, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and do all lawful acts requisite for the application, for such divisional, continuing or reissue


applications or the procuring thereof, and I further covenant and agree that I will, at any time upon request, do everything legally possible to aid said ZEISS JENA, its successors, assigns, nominees or other legal representatives, either in its or their own name, to maintain and enforce any patent for said improvements without further consideration but at the expense of said ZEISS JENA, its successors, assigns, nominees or other legal representatives.
