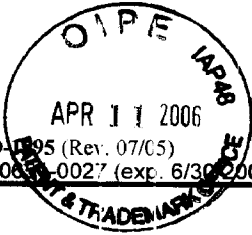

### ASSIGNMENT


