UTILITY PATENT

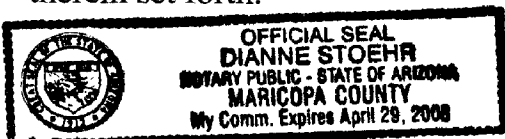
