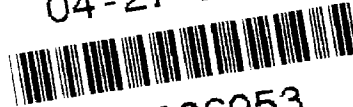

ASSIGNMENT

WHEREAS, We, **William Bogue**, of 1 West Main Street, Hebron, CT 06248 and **Richard B. Ringler**, of 210 Cranberry Lane, Middletown, CT 06457, have invented certain improvements in a WEDGE REPAIR OF MECHANICALLY RETAINED VANES, identified as Attorney Docket No. PA-0000908-US(05-754), and described in a patent application executed by the undersigned on the dates set after the signatures hereto, being owners of all right, title and interest in and to said application and in and to any invention described therein, free from all prior assignments, agreements, licenses, mortgages, or other encumbrances whatsoever, and having full right to convey the entire interest both legal and equitable herein assigned; and

The undersigned further agrees, without any further payment or compensation by said assignee or its successors and assigns, to communicate to said assignee, its representatives or agents or its successors and assigns, any facts relating to said invention or inventions including evidence for interference purposes or for other legal proceedings whenever requested; testify in any interference or other legal proceedings, whenever requested; execute and deliver, on request, all lawful papers required to make any of the foregoing provisions effective; and generally do everything possible to aid said assignee, its successors or assigns and nominees to obtain and enforce proper patent protection for said invention or inventions in this or any foreign country.
