

ASSIGNMENT

And for the consideration aforesaid, I agree that I will communicate to said Assignee or the representatives thereof any facts known to me respecting said inventions and improvements, and will, upon request, but without expense to me, testify in any legal proceedings, sign all lawful papers, make all lawful oaths, and generally do all other and further lawful acts, deemed necessary or expedient by said assignee or counsel for said assignee, to assist or enable said assignee to obtain and enforce full benefits from the rights and interests herein assigned. This instrument shall be binding upon my heirs, executors, administrators, and assigns, and shall inure to the benefit of the heirs, executors, administrators, successors, and assigns, as the case may be, of said Assignee.
