NAME

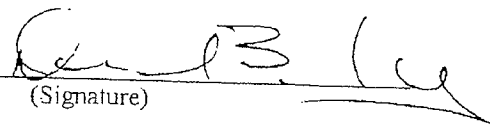
The name of this corporation is "Intellisum, Inc."
