

**ASSIGNMENT OF DESIGN**

**WHEREAS, I, GAYLON G. WALBEY, JR.**, residing at 3872 FM 350 S. Livingston, Texas 77351, have invented an ornamental design disclosed in an application for United States Letters Patent entitled VEHICLE-WHEEL FRONT FACE, and executed by me on even date herewith;

**AND I HEREBY** covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;

**AND I HEREBY** further covenant and agree that I will communicate to ASSIGNEE any facts known to me respecting said design, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute and reissue applications, make all rightful oaths

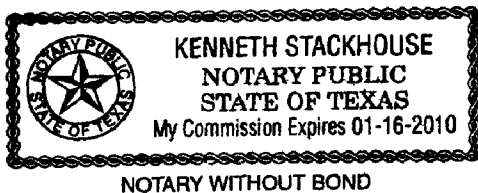
and generally do everything possible to aid ASSIGNEE to obtain and enforce proper patent protection for said design in all countries.
