PATEL**; (2) **Jason FISH**; (3) **Dany GAUDET**; and (4) **Lafliche GAGNON** of (1) 5922 Long Valley Rd., Mississauga, Ontario L5M 6K4, CANADA; (2) 27 Sir Michael Place, Brampton, Ontario L7A 1Z4, CANADA; (3) 2623 Julien, Longueuil, Quebec J4L 2L9, CANADA; and (4) 1554 Octave-Crémazie, Ste-Julie, Quebec J3E 1N8, CANADA have invented certain new and useful improvements in **INTERNAL FUEL MANIFOLD WITH TURNED CHANNEL HAVING A VARIABLE CROSS SECTIONAL AREA**, hereinafter the invention, for which we have made an application for letters patent of the United States.

said invention, and for maintaining and perfecting the Assignee's right to said invention and letters patent, particularly in cases of interference and litigation.
