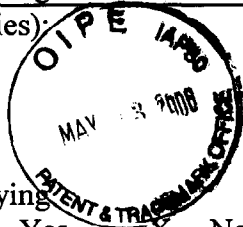

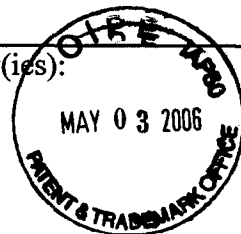

Whereas We, Peter H. Corsini, whose residence address is 7 Marshview Circle, East Sandwich, MA 02537, Ryan C. 
