ASSIGNMENT

AND, RMD HEREBY further covenants that RMD has the full right to convey the interest assigned by this Assignment, RMD will take all action and execute all documents necessary to perfect the interest assigned hereby, and RMD has not executed and will not execute any agreement in conflict with this Assignment;

AND, RMD HEREBY further covenants and agrees that RMD, through its officers and employees, will, without further consideration, communicate with Manfredi, his successors, heirs and assigns, any facts known to RMD and its officers and employees respecting the invention and testify in any legal proceeding, sign all lawful papers when called upon to do so, execute and deliver all papers that may be necessary or desirable to perfect the title to the invention in said Manfredi, his successors, heirs and assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything possible to aid Manfredi, his successors, heirs and assigns, to

obtain and enforce proper patent protection for the invention in the United States and any foreign country.
