

3. Certification and issuance of stock certificates shall be subject to the provision of Article 161.1 of Company Law. In the event of any violation, it shall be imposed a fine for more than NT\$10,000 and not more than NT\$50,000. If it still fails to issue stocks at expiration, it shall continue pushing to issue before the time limit, and a fine for more than NT\$20,000 and not more than NT\$100,000 shall be successively imposed on case-by-case basis until the stocks are issued.
4. According to Business Tax Law, you shall apply for change of profit-seeking enterprise registration within 15 days after the present approval.
5. Enclosed please find one original form of Registration List for Change of Company.
6. In case of disagreement with the present decision, you are entitled to file the petition to National Science Council, Executive Yuan through this Administration within 30 days after service of the present written decision.
