



## SETTLEMENT AGREEMENT, LICENSE AND MUTUAL RELEASE

This Settlement Agreement, License and Mutual Release (the "Agreement") is entered into as of June 23, 2006 ("Effective Date") by and between the parties of the First Part and the party of the Second Part:

First Part: Manheim Auctions, Inc. ("Manheim"), a corporation organized and existing under the laws of the State of Delaware, with its principal place of business and corporate headquarters in Atlanta, Georgia, and Manheim Services Corporation ("MSC"), an indirect wholly owned subsidiary of Manheim Auctions, Inc., also a corporation organized and existing under the laws of the State of Delaware, with its principal place of business and corporate headquarters in Atlanta, Georgia. Unless otherwise noted, hereinafter references to Manheim shall be deemed to include MSC.

Second Part: Copart, Inc. ("Copart"), a corporation organized and existing under the laws of the State of California with its principal place of business and corporate headquarters in Fairfield, California.

### BACKGROUND AND RECITALS

WHEREAS, MSC represents and warrants that it is the owner by assignment of United States Patent No. 5,774,873, entitled "Electronic On-Line Motor Vehicle Auction And Information System," issued June 30, 1998 (the "'873 Patent") and U.S. Patent No. 6,006,201, entitled "Electronic On-Line Motor Vehicle Auction And Information System," issued December 21, 1999 (the "'201 Patent") and that there are no other patents or pending applications depending from either the '873 patent or the '201 patent (collectively "the MSC Patents");

WHEREAS, MSC filed a Complaint for patent infringement against Copart on June 10, 2005 in the United States District Court for the Northern District of Georgia, captioned Manheim Services Corp. v. Copart, Inc., Civil Action No. 1:05-CV-1527-WSD ("the MSC Action"), in which MSC alleged infringement of the '873 Patent and in which MSC subsequently sought to add a claim for infringement of the '201 Patent;


