ASSIGNMENT

WHEREAS, We, ANDREAS HAUG, residing at Franklinstr. 77, D-70435, Stuttgart, Germany; TOM SCHÖNHERR, residing at Argonnenstr. 22, D-70374 Stuttgart, Germany; ANDREAS DIMITRIADIS, residing at In den Weingarten 14/1, D-73547 Lorch, Germany and PETER KOLIN, residing at Hardtstr. 14, D-73525 Schwäbisch Gmünd, Germany, have invented a new original and ornamental design for a SHOWERHEAD BRACKET for which we have made application for Letters Patent of the United States of America; and

FOR SAID CONSIDERATIONS, we hereby covenant and agree that we are the owner of the full title herein assigned and have the right to assign the same, and agree that we will

communicate to said corporation or its representatives, any facts known to us respecting said invention or inventions and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which in the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned.


