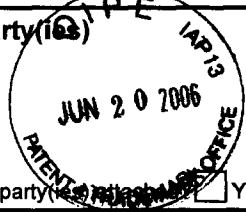

B. Assignor wishes to convey the Patent to Assignee and Assignee wishes to receive same from Assignor.




