

THIS ASSIGNMENT, made by me, **Dennis R. Strauss**, a citizen of the United States of America, residing at 21 Azusa Avenue, Ventura, California 93004,

WITNESSETH: That,

WHEREAS, I am the sole inventor of certain new and useful improvements in **PHOTOLITHOGRAPHIC METHOD AND APPARATUS EMPLOYING A POLYCHROMATIC MASK** for which an application for United States Letters Patent has been executed by me concurrently herewith, and
