**TERMINATION AND RELEASE OF SECURITY INTEREST
IN SPECIFIC PATENTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN SPECIFIC PATENTS (the "Termination and Release"), dated July 28, 2006, is by and among JPMorgan Chase Bank, N.A., as Administrative Agent (together with its successors and assigns, the "Agent") under that certain Amended and Restated Credit and Guarantee Agreement dated as of November 12, 2004 (as amended, supplemented or otherwise modified from time-to-time, the "Credit Agreement") among Bush Industries, Inc. (the "Pledgor"), Röhr-Bush Industries GmbH & Co. (together with the Pledgor, the "Borrowers"), the lenders party thereto (the "Lenders") and the Agent.

WHEREAS, Agent previously entered into a Collateral Agreement dated as of December 28, 2001, with the Pledgor and certain subsidiaries of the Pledgor, which was recorded in the United States Patent and Trademark Office on May 13, 2002 at reel/frame no. 012875/0819 (as amended, supplemented or otherwise modified from time-to-time, the "Collateral Agreement");

WHEREAS, the Collateral Agreement included a pledge and grant of security interest in and to the Patents (as defined in the Collateral Agreement) including without limitation the Patents owned or used by Pledgor set forth in Exhibit A hereto (the "Released Patents");

WHEREAS, the Borrowers and certain of their affiliates are entering into certain new credit facilities to be established on or around the date hereof (the "Bank of America Credit Facilities") with Bank of America, N.A., as Administrative Agent;

WHEREAS, in connection with the establishment of the Bank of America Credit Facilities, the Borrowers, the Lenders and the Agent are entering into an Amendment No. 3 to Amended and Restated Credit and Guaranty Agreement (the "Credit Agreement Amendment"), amending the Credit Agreement;

WHEREAS, in connection with the Credit Agreement Amendment and the establishment of the New Credit Facilities, the Pledgor has requested that the Agent terminate and release its security interest in the Released Patents and the Agent has agreed to such termination and release;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged the Agent and the Pledgor hereby agree as follows:

Agent hereby terminates and releases all of Agent's security interest in the Released Patents.

Agent authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable United States government officer record this Termination and Release.

This Termination and Release may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single agreement.


