

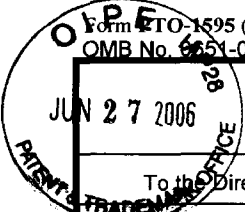

WHEREAS, I, Jonathan Kelsey ("Assignor"), citizens of the United Kingdom, have invented a new, original, and ornamental design for a


