

And for the same consideration, the ASSIGNOR(S) hereby covenants and agree with GLIDDEN that at the time of execution hereof, ASSIGNOR(S) are the sole and lawful owners of the entire right, title and interest in and to the said improvements, inventions and application for Letters Patent identified above and that the same are unencumbered and that

ASSIGNOR(S) have good and full right and authority to sell and convey the same as set forth above.


