ASSIGNMENT

c. to perform all affirmative acts and take all lawful oaths that may be necessary or required to obtain a grant of a valid patent to the Assignee on the Patent and on any continuation, continuation-in-part, divisional, reissue or reexamination of the Patent in any country, and for the procurement, maintenance, enforcement, and defense of Letters Patent or Patents for the inventions described and claimed therein, without charge to the Assignee, its successors, legal representatives, and assigns, but at the cost and expense of the Assignee, its successors, legal representatives, and assigns.

The Assignor hereby covenants that, at the time of execution and delivery of the present assignment, the Assignor is the sole and lawful owner of the entire right, title, and interest in and to the inventions set forth in the Patent identified above, and has the full and complete right, title, and interest to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict therewith.

The undersigned has reviewed the documents in the Patent identified above and, to the best of undersigned's knowledge and belief, title is in the Assignor identified above.

The undersigned is empowered to sign this assignment on behalf of the Assignor.
