This Assignment is being delivered pursuant to, and subject to the representations, warranties, covenants and agreements set forth in, the Purchase Agreement. Nothing herein shall be construed to expand, diminish or modify any of the rights or obligations of the parties set forth in the Purchase Agreement.
