This Agreement is entered into and is effective as of December 16, 2004, by and between the following parties:

PARADYNE WORLDWIDE CORP., a Delaware corporation under the laws of the United States, and
PARADYNE FINANCE CORP., a Delaware corporation under the laws of the United States ("Debtors/Guarantors").






