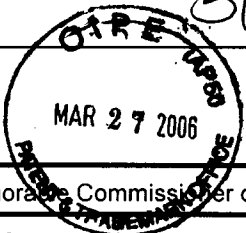


**REMARKS**
